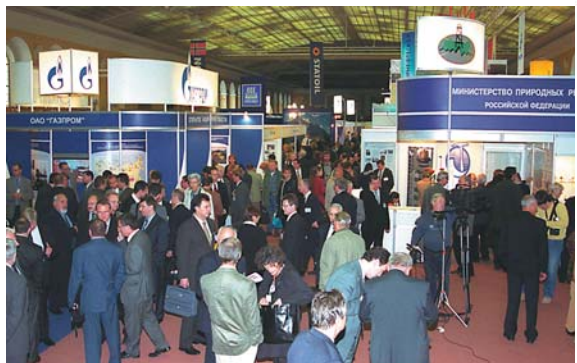

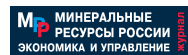

Arctic Monitoring and Assessment Programme

The Arctic Council, a high level forum of the Arctic countries, requested the Arctic Monitoring and Assessment Programme (AMAP), in collaboration with the other working groups of the Arctic Council, to present to the Ministerial meeting in 2006 the assessment report on oil and gas activities in the Arctic. This report will cover all aspects of exploration, exploitation and transportation of hydrocarbons in the region, including environmental, social and economic impacts.

A special expert group has started to gather data and information relevant to this assessment. In order to get and discuss additional information for the evaluation report of both shelf, and land areas of the Arctic, within RAO/CIS Offshore 2005 the symposium «**Prospects and Consequences of Development and Exploitation of Oil and Gas Fields in Arctic**» will be arranged.

INFORMATION FOR AUTHORS OF PAPERS

Official languages of RAO/CIS Offshore 2005 are Russian and English. Simultaneous translation of presentations and speeches as well as interpreters for lobby interviews provided.

Those who are interested in delivering a paper at the conference should fill in and forward to the Secretariat a notification about their intention to participate in the conference and annotation of a paper. The size of material is 1/2 page in A4 format.

A preliminary programme of RAO / CIS Offshore 2005 will be ready **by July 1, 2005** and sent to all registered participants and other persons concerned.

Before **July 15, 2005** the authors should send the texts of their reports to the Secretariat by e-mail. Along with the text of such report it is necessary to enclose an official permit for publication in open press.

By the beginning of the RAO / CIS Offshore 2005 based on materials provided by authors **RAO / CIS Offshore 2005 Proceedings** will be prepared.

Reports will be published in the RAO / CIS Offshore 2005 Proceedings only provided that deadline for the submission to the Secretariat has been met, as well as an official permit for publication and payment of a registration fee.

REQUIREMENTS SET FOR PAPERS PUBLICATIONS

The size of material should be not more than 8 pages in A4 format (approximately 15 000 printed characters) including illustrations and references.

The electronic version of a paper shall be done in Microsoft Word editor and forwarded to the Secretariat by e-mail: rao@restec.ru.

The title (subject) of a message shall contain the text «RAO/CIS Offshore 2005 paper» and the text of the message shall contain the title of a paper, the name of an author and contact phones.

The title of a paper shall be written with capital letters, below there shall be written names and last names of authors and place of work.

The main text of a paper shall be anticipated by an annotation in English containing 50-60 words.

Illustrations (including formulas, drawings and diagrams) should be printed in the order of their mentioning. Illustrations should be numbered in the order of their mentioning and have captions under illustrations.

*Only the use of black-and-white pictures (bitmap) with *bmp or *tif tags is admissible. The size of illustrations in width is not more than 160 mm, in height - not more than 200 mm, resolution is 300 dpi.*

All the illustrations used should be enclosed in the form of separate graphics files.

Formulas shall be clear, done with the use of computer or scanner. All formulas are included in a document as graphic images (illustrations).

The use of tables in the text is undesirable. If necessary, tables shall be performed with the use of standard Microsoft Word means.

EQUIPMENT

To demonstrate their illustration materials the authors of papers will be provided with projectors for transparent film, multimedia projectors and screens. All the halls are equipped with flip charts, blackboards and felt-tip pens.

Presentation materials may be performed on transparent films in A4 format or in the form of a Microsoft PowerPoint 97 presentation.

We recommend you to forward your presentation to the Secretariat in advance or use your own PC. In any case we ask you to coordinate with technical staff all questions before the beginning of a session or in a break.

TERMS AND CONDITIONS OF PARTICIPATION IN THE CONFERENCE AND AMAP SYMPOSIUM
