- To build long-term trust and partnerships






"A good knowledge basis" – is another key to success of the BSAP

- Examples from a recently produced Swedish report "The agricultural impact upon the Baltic Sea – a comparison of indicators to describe the nutrient pressure"






Rural development program 2007-13 Support for environmentally friendly agriculture






Rural development program 2007-13 Support for environmentally friendly agriculture








Nitrogen, mean leakage per unit area

Full harmonisation with the WFD process - another key to success of the BSAP

- Farmers around the Baltic Sea are now approached from two un-coordinated water environment communities – BSAP & WFD
- Farmers around around the Baltic Sea expect that two public policy and administrative processes with almost identical objectives should be fully co-aligned





Impact assessments – another key to success of BSAP

 BFFE believe that carefully prepared <u>economic and social impact</u> <u>assessments</u> of the forthcoming national action plans are important to seriously address the concerns of the sectors expected to take the lion's share of the nutrient reduction burden





The EU Baltic Sea Region Strategy -– another key to success of BSAP

- BFFE and other farmer organisations have proactively contributed with own inputs and proposals to meet the targets of the BSAP and other prominent objectives of the strategy

Additionally, together with the WWF: A new **Baltic Farmers' Award**

- Mature discussions on this, not everything settled...
- To stimulate voluntary measures to reduce runoff on farms around the Baltic Sea
- Nominations from all countries around the Baltic based on national nomination groups
- A "substantial" amount of money and the price will be handed over at major Baltic event
