In order to make the administration of your stay and participation in the events easy, we would ask that you retain and provide to the organizers on arrival in Ho Chi Minh the following information / document:

Airline E-Ticket or paper based original
Original receipt of Invoice amount paid to travel agent (if applicable)
Taxi Fare receipt from home / business to embarkation airport to Saigon

Speakers or delegates of the Mekong Environment and Climate Symposium financially supported by MRCS will receive a Daily Subsistence Allowance (DSA) which includes meals and accommodation. Other related travel expenses such as taxi fares home-airport-home and also between the accommodation and meeting venue will be reimbursed base on MRC policy and receipts. You will be provided a full DSA minus deductions of some meals provided during the Symposium. The calculation is based on the number of days you stay for the event (s).

With the DSA provided, you are expected to pay your own hotel bill and other ancillary cost.
