In addition to informal discussions during the meeting, participant in five component-specific working groups considered the following questions.

- Communications—What new communications mechanisms might be effective with respect to this Component?
- Planning—Are there activities or omissions in the existing Component that need to be reconsidered?





Selected Communications recommendations included:

- Existing mechanisms
- New linkages between regional and national centres
- Output-oriented AFFs that focus on previous AFF recommendations
- Dissemination of information directly to local communities, as well as through province, district and commune levels
- Regional meetings on special FMMP technical topics.
- Engaging partners more fully in the FMMP







Selected planning recommendations included:

- 1. Provide detailed Project Implementation Plans
- 2. Perform cost-benefit analysis and estimate benefits
- 3. Emphasize consensus building
- 4. Training on drafting emergency plans
- 5. Conserve biodiversity, wetlands, reforestations, and conserve flood-retention zones





Recommendations for the Fourth Annual Mekong Flood Forum

- More output-oriented forums that follow up on recommendations from previous forums
- Successful examples, lessons learned, and future plans for the implementation of the FMMP in all MRC countries
- MRC's forums and meetings should cover wider audiences



Summary



- Participants supported the Forum and had numerous recommendations about improving FMMP implementation
- The MRCS stated that group discussions provided feedback on the FMMP and pledged to take the recommendations under consideration as the FMMP is implemented.
