

5. Area Tables and Maps

Protection categories and criteria used in the Area Tables:

A. Strict protection

By strict protection in this context is meant that nature protection is the dominant interest in the area, and that nature conservation is the dominant form of land use. Such strict protection could, however, also include a certain degree of human influence in the form of, e.g., organized grazing or hay-making (mowing). Such activities are then carried out exclusively in the interest of nature conservation.

A 1. Various forms of constructions and installations – single buildings, various recreational facilities, commercial centres, marinas, etc – are not allowed.

A 2. Intense, highly mechanized, large-scale forestry – including the use of mechanized land preparation, fertilization, use of pesticides, etc – is not allowed.

A 3. Intense, highly mechanized, large-scale agriculture – including the use of mechanized land preparation, fertilization, use of pesticides, etc – is not allowed.

A 4. Extraction of natural resources – oil, peat, sand, clay, gravel, etc. – is not allowed.

B. Moderate protection

By moderate protection in this context is meant that nature protection is an important interest, which places limitations on the overall land use. There could, however, also be multiple land use satisfying other interests.

B 1. Some infrastructure developments could be allowed but are kept under strict control by the authorities. A special permit from the authorities must be granted for each such construction. For instance, minor roads may be built in the area, power or telephone cables may be extended through the area.

C. Wildlife protection

C 1. All access to the area, including landing, is prohibited during breeding seasons or other periods particularly sensitive in the lifecycles of seals, birds or other animals in coastal or marine areas. During those periods, access is prohibited for all visitors. However, access is allowed during the rest of the year.

IUCN Management Categories and Criteria for Protected Areas

I Strict Nature Reserve. Wilderness Area

Protected area managed mainly for science or wilderness protection.

II National Park

Protected area managed mainly for ecosystem protection and recreation.

III Natural Monument

Protected area managed mainly for conservation of specific natural features.

IV Habitat / Species Management Area

Protected area managed mainly for conservation through management intervention.

V Protected Landscape. Protected Seascapes

Protected area managed mainly for landscape or seascapes conservation and recreation.

VI Managed Resource Protected Area

Protected area managed mainly for the sustainable use of natural ecosystems.
