



LEGAL DOCUMENT ON WATER RESOURCES

- 1. The Law on Water Resource (May 1998)
- 2. Decree No.179/1999/ND-CP stipulating implementation of the Law on Water Resources (Dec. 1999)
- 3. Decree No.149/2004/ND-CP licensing exploitation, extraction and utilisation and waste water discharge in water sources (2004)
- 4. Decree No.34/2005/ND-CP on sanctions against administrative violations of water resources management regulations (Mar. 2005)
- 5. Circular guiding implementation of the Decree No.34/2005/ND-CP providing for sanctions against administrative violations of water resources management regulations (Jul. 2005)

Organizations and individuals entitled to exploit and use the water resource for life and production


All taken full responsibilities to protect the water resource, prevent and overcome harmful effect may caused by water resources



National Water Resources Strategy towards the Year 2020

Decision 81/2006/QĐ-TTg on 14 April 2006

- Aiming at strengthen protection, exploitation, utilization and development of water resources, prevention and mitigation of adverse impacts caused by water
- Accompanying with 18 priority projects for the period 2006-2010





Guiding Principles

- Strategy implemented in comprehensive manner with concentration on national development targets
- Management, protection and development of water resources reflected the integration nature of river basin, including aquatic and ecological systems
- 3. Enforcement and effectiveness of the State management of water resources strengthened
- Socio-economic development plan based on real potentials of the water source
- 5. Water utilization oriented to multi-purpose approaches, incorporating interests of sectors, localities and communities to ensure highest socioeconomic efficiencies and balanced development and protection
- 6. The State shall ensure necessary resources with appropriate policies to sustainable development and protection of the water resources



Missions

- 1. Enhancing protection of water resources and aquatic eco-systems
- 2. Ensuring sustainability and effectiveness in exploitation and use of water resources
- 3. Sustaining development of water resources
- 4. Mitigating adverse impacts caused by water
- 5. Improving institutional arrangements
- 6. Strengthening capacities in basic investigation, scientific research and technology development



Overall objective

Protection, exploitation and sustainable development of water resources on the basis of integrated and unified management to meet water demands for people's living and socio-economic development while ensuring national defence and security and environmental protection and mitigation of adverse impacts caused by water



Specific Objectives

- 1. Protection of water resources
- 2. Exploitation and utilization of water resources
- 3. Water resources development
- 5. Strengthen of institutional capacity in water resources management



Measures to Implementation

- 1. Communication, education, public awareness improvement and encouragement of community participation
- 2. Strengthening legislation and Institution
- 3. Increasing public investment and enhancing community participation in the provision of water services
- 4. Development of human resources, science and technology
- 5. Extension and improvement of international cooperation
- 6. Renovation of financial mechanisms



Priorities to Implementation of the National Water Resources Strategy in the Period 2006 - 2010

- 1. Inventory and assessment of national water resources and establishment of national water resources information and data system
- Water resources sharing with priority given to domestic uses and securing water for power generation of key hydropower plants in cases of drought occurrence
- 3. Ensuring water security for provinces with severe water shortage by water allocation and regulation
- 4. Re-structuring cropping patterns for a more economical and efficient water use
- 5. Development of regulatory reservoirs operational rules for major river basins
- 6. Protection and preservation of groundwater in large cities
- Implementation of community participation in water service provision, development of multi-sectoral water industries in accordance with a socialistoriented market economy
- 8. Protection of precious aquatic species
- Ensuring environmental flows, maintaining aquatic eco-systems and hydropower reservoirs and dams.





Priorities to Implementation of the National Water Resources Strategy in the Period 2006 - 2010

- 10. Protection and rehabilitation of protective forests for major watersheds
- 11. Development of the management mechanism of irrigation and hydropower reservoirs for economy and tourism development, environment protection and improvement of people's living standard
- 12. Bilateral cooperation with neighbouring countries in water resources basic survey, information and data sharing, protection, exploitation and uses of transboundary water sources
- 13. Rehabilitation and modernisation of the sea dyke systems
- 14. Revising and amending the Law on Water Resources
- 15. Developing economic tools for water resources management
- 16. Communication and improvement of public awareness on water resources
- 17. Developing curricula on water resources at different education levels
- 18. Mobilization of Nation-wide involvement in water resources management and protection











Bilateral cooperation

- Assisting each other in implementation of MRC programs (elaboration and implementation of rules/procedures on Water utilization)
- Promoting exchange of data/information related to development in upstream parts
- Facilitating bilateral cooperation between relevant ministries, sectors
- Formulating joint projects in 3-S zone under ADB initiation (Lao Cambodia Vietnam) and Join projects in Mekong delta under assistance of WB (Vietnam Cambodia)
- Strengthening capacity building in interested fields (technical and managerial fields)
- Exchange visit at various levels for promoting cooperation anddiscussion on issues of mutual concern



Lessons and Experiences from regional cooperation


- Well directed by national LAWs and Policies
