Executive Summary

This 2nd Progress Report for the Pacific SIDS Integrated Water Resources Management Planning Programme (Pacific IWRM Planning Programme) covers the period July to December 2009 of project implementation. The report illustrates the programme's achievements, its progress against the logframe and demonstrates the harmony with which the EU and GEF IWRM programmes co-exist.

The EU IWRM Planning Programme

Over the last six months progress has been balanced between regional activities supportive of national initiatives as well as support to country IWRM initiatives themselves.

Of the six result areas of the IWRM Planning Programme, to date the most progress has been made with the development of a functioning IWRM resource centre. This has been made available for countries to use to improve their understanding of IWRM and Planning with a view to developing their own country programmes when seeking support. The Resource Centre also established more defined links with Global networks such as the Asia Pacific Knowledge Hubs over the last six months a pivotal role to capture lessons learnt and best practices from other Small Island Developing States (SIDS).

The recruitment of the Mainstreaming and Indicators Advisor (MAIN) in December 2009, a key achievement in the last six months is an essential element to develop a robust Regional Indicator Framework (RIF).

Similarly, raising awareness on IWRM through the work of the Communications Advisor and production of Information, Education and Communication (IEC) Materials has been given considerable attention as well. The IEC materials developed as a result of these efforts (see Table 4 and 6) have been circulated widely to partners, stakeholders and other interests groups. The Resource Centre and communications work have jointly contributed to partnership promotion activities as well.

Alongside these activities, work has also been carried out on supporting national IWRM initiatives (see Table 8 and 9) which includes the following:

- · Finalising the Samoa- Water Sector Investment Plan,
- Finalising Niue- Least Cost Analysis for water supply options to present to cabinet,
- On-going support to the Kiribati- National Sanitation Policy and Implementation Plan,

The programme has also picked up on further country requests and is in the process of providing concrete assistance to them

- Niue request to review to develop an IWRM Plan for Niue,
- Nauru- request to support the development of a National Water and Sanitation Policy Framework.

The IWRM Planning Programme to date continues to support staff in country to help them coordinate their in-country including the Marshall Islands, Tonga and Niue; however the Marshall Islands have decided to re-organise this support in other ways (see 4.1.2). As always, support to National Water Committee operations and consultations are ongoing.

Furthermore, capacity building efforts are on-going as well through facilitation of regional and interregional meetings and trainings which are mentioned below:

- Facilitating GEF Inception and Regional Steering Committee Meeting (RSC)
- Developing special training programme for the Niue Water Committee Policy Officer in issues pertaining to IWRM along with other selected participants.

While a summary of key EU IWRM Planning Achievements can be found in Table 1 below a more comprehensive overview of the programme's work can be found in Section 4.2 (Table 9).



Although progress made in moving forward the Planning programme, challenges still remain which are highlighted in Section 6 and 6.1 of the report.

Moreover the initial setbacks faced with staffing losses and responsibility of jointly coordinating the GEF IWRM Project has had an inverse impact on the original Planning Programme timelines. In light of this and in accordance of the recommendation made in the ROM review, with the submission of this 2nd Progress Report for the period July-December 2009, the following request is being put forward for consideration for which a formal request will follow this submission.

• A no-cost one year (12 month) extension to the Planning Programme original timeline in order to fully meet Programme objectives.
