# REGIONAL TECHNICAL ADVISORY GROUP (RTAG) 1ST MEETING MINUTES

#### 1. Recommendations

# 3.4 Terms of Reference

Terms of Reference from RSC Item 2.6 adopted unchanged. Moved Milika Sobey. Seconded Leerenson Lee Ariens. Accepted unanimously.

Development of science symposium prior to RSC proposed as an additional task of the RTAG, with the opportunity to invite scientists from around the world to present new technology and developments.

# Action:

 Rhonda Robinson and Chris Paterson to draft a paper to the RSC outlining options to run a science symposium prior to the RSC meetings.

Marc Wilson highlighted that project funding was only available for the two RTAG meetings scoped in the Project Document. However, additional external funding was available for an additional RTAG meeting in September 2010 to finalise indicator frameworks.

# 3.5 Development of Project Monitoring and Evaluation Framework

David Duncan presented on the project monitoring and evaluation framework needs. It was identified that there was a need to revise the project monitoring and evaluation framework due to changes to national project logframes.

Jose Padilla highlighted that the project monitoring and evaluation framework could be revisited, albeit that it was already late in the project life to be doing this. He also highlighted the need to complete the GEF tracking tools as soon as possible.

### **Actions:**

- Sopoaga Sam Semisi and Leerenson Lee Ariens to lead coordinating information from countries for project indicators. Science and Technical experts to undertake technical review of the project monitoring and evaluation framework and liaise with Sam Semisi and Leerenson Lee Ariens. Deadlines for information request response – two weeks.
- Recommendation be put to RSC that the Draft Project Monitoring and Evaluation Framework be considered for endorsement out of session. Deadline for information requests passes to coordinators 2 weeks.
- Draft Project Monitoring and Evaluation Framework to be presented at an RTAG meeting in September

# 3.6 Development of a Regional Indicator Framework

David Duncan presented on the Regional Indicator Framework needs. It was identified that there was a need to revise the project monitoring and evaluation framework due to changes to national project logframes.

### Actions:

 The RTAG technical experts are to provide a Draft Regional Indicator Framework for RTAG and country consideration by February 2011.

Open discussions were held on the timing of the mid-project review. It was agreed that the mid-term review would be held in September 2011.

# **Actions:**

 Ampai Harakunarak (UNEP) and Jose Padilla (UNDP) to arrange for project mid-term review in September 2011 with the view of completion of the review by the end of 2011

## **4 UNEP Pacific Water Vulnerability Assessment**

David Duncan presented the Pacific Water Vulnerability Assessment to the RTAG for review. Comments were invited on the method with the view of seeking endorsement from the RTAG. **Actions:** 

- RTAG members to review Pacific Water Vulnerability Assessment and provide comments to David Duncan
- David Duncan to deliver Pacific Water Vulnerability Assessment for RTAG and PSC endorsement by September 2010
