Update of the YSLME SAP

1. This report was prepared by Prof. Paul GREMILLION, the international TDA/SAP development consultant contracted by UNOPS to assist in the update of the TDA and SAP under the guidance of the RWGs, MSTP and UNDP/GEF in consultation with the PMO.

Introduction

- 2. In the 3rd Meetings of the MSTP and ICC held on March 12-14, Qingdao, PR China, the partners reviewed the process and timeframe to update and adopt the transboundary diagnostic analysis (TDA) and Strategic Action Programme (SAP) of the YSLME and requested the Secretariat and the international consultant to proceed with preparation of the updated TDA and SAP as planned with participation of relevant stakeholders.
- 3. During the 3rd YSLME Science Conference held on July 15-19, 2019, Qingdao, PR China, the SAP update workshop reviewed and validated the key components of the 2007 TDA and updated the management actions of the 2008 SAP. The SAP workshop also realized that the updated TDA should be finalized and adopted in the first place to enable countries to discuss objectives, targets and management actions of the SAP.
- 4. Based on the findings of the SAP update workshop and taking into account the need for extensive consultation at national levels to develop a set of management actions in line with national priorities in updating of the SAP, a workplan and steps was prepared for review at the ICC-4 to guide the preparation and approval of SAP for implementation.

Recommendation

- 5. The Secretariat recommends that:
 - a. the 4th Meeting of the ICC:
 - i. review and refine the workplan to contextualize with national approval processes for implementation by the two countries;
 - ii. direct the Secretariat to fully integrate the activities therein in the two-year workplan 2019-2020; and
 - iii. request the Secretariat to coordinate the preparation and submission of the final version of updated SAP for adoption at the next meeting of the ICC scheduled in 2020.
