Executive Summary

The Project Inception Workshop is scheduled on July 11-13 in Seoul, RO Korea. On the development of YSLME into a sustainable regional arrangement, the project supported a consultancy to prepare a roadmap to enable the stakeholders to have a clear understanding of the key elements of the institutional framework, process, a feasible plan on how to launch the YSLME Commission at the early stage of implementation of the Project. With regards to supporting services of the YSLME, subsequent to the identification of Rudong Xiaoyangkou as a site to be established as a potential MPA in the first quarter, the project supported the preparation of a technical proposal to list Xiaoyangkou as a national MPA at the request of local Ocean and Fisheries Bureau. It is expected that the proposal will be completed in October to facilitate the inclusion in the YSLME MPA Network. To restore the provisioning services, PMO has launched vacancy announcement for preparing training modules for integrated multi-tropic aquaculture. Meanwhile, a new meeting room for use in conduct of training courses on integrated multi-tropic aquaculture is being built in Sungo Bay, Rongcheng of Shandong Province, the first demonstration site of IMTA during the first phase of the project. The room will be used to train aquaculture practionners in coastal provinces of YS in PR China, RO Korea and other countries in other LMEs. The project is now undergoing a bidding for the services of developing a project website. In addition, the project has also launched the Internship Program to join the PMO team to construct the website and establish a clearing house of environmental laws in Yellow Region. A total of US\$243,469 has been disbursed from January 1 to June 30, 2017, representing 14 percent of the budget for 2017.

The following recommendations are proposed for consideration:

Implementation of AWP 2017:

- a) By August 20, the Secretariat complete all major TORs for consultancies;
- b) The Secretariat consult relevant RWG Chairs and Vice Chairs in writing on the methodologies and TORs of consultancy services;
- c) The Chairs and Vice Chairs of relevant RWGs communicate and provide joint responses to the request of the Secretariat within 10 working days; and
- *d)* The Secretariat closely follow up the implementation of the contracts to ensure timely submission of deliverables by the consultants or subcontractors.

Engaging DPR Korea:

- e) The Secretariat consider organizing more events in China at the border city with DPR Korea, i.e. Dandong of Liaoning Province, or Secretariat Dalian Branch, to allow participation of DPR Korea counterparts in project activities possible and in a cost-efficient manner; and
- f) Furthermore, the Secretariat explore opportunities of financial support from UN Agencies or organizations with field operations in DPR Korea to facilitate the participation of DPR Korea colleagues in project meetings and workshops.

- 3, the request for quotations for website development was uploaded and more than 3 quotations were received before the deadline of June 30.
- 4, A new meeting room for use in conduct of training courses on integrated multi-tropic aquaculture is being built in Sungo Bay, Rongcheng of Shandong Province, the first demonstration site of IMTA during the first phase of the project. The room will be used to train aquaculture practionners in coastal provinces of YS in PR China, RO Korea and other countries in other LMEs.
- 5, a Seminar on Marine Protected Areas in YSLME and North-East Asia is being planned on Ganghwa Island on July 14 in collaboration with Ganghwa County. A field trip will also be organized for participants at project Inception Workshop.

YSLME Voluntary commitments to the UN Ocean Conference. On June 10th, 2017, New York, the 193 Member States of the United Nations unanimously agreed to accelerate action to stop and reverse environmental degradation of oceans at the largest ever gathering of states under the UN umbrella - the UN Ocean Conference to Support the Implementation of Sustainable Development Goal 14, convened in New York from 5 to 9 June 2017. The Ocean Conference, the first UN conference of its kind on the issue has raised global consciousness of ocean problems ranging from marine pollution to illegal and over fishing, from ocean acidification to lack of high seas governance. The YSLME initiatives contributing to the implementation of Sustainable Development Goal 14 were registered as "Voluntary Commitments" and introduced YSLME SAP with identification of 11 regional targets aimed at restoring and maintaining the ecosystems capacity. Specifically, the YSLME Project has registered to achieve the following three deliverables as commitments to the SDG 14: 1) By December 2019, establish the YSLME Commission as a non-legally binding collaboration arrangement, 2) By December 2019, 25-30% of fishing boats are reduced using the year 2004 as the baseline to relieve the pressure on fish stocks; and By December 2020, 10 Marine Protected Areas (MPAs) are created in YSLME to contribute to 10% coverage of coastal and marine areas under conservation and management, using 2009 as the baseline.

3.3 Management Recommendations

Implementation of the AWP 2017

A total of US\$243,469 has been disbursed from January 1 to June 30, 2017, representing 14 percent of the budget for 2017. Breakdown of the project expenditure by Activity (Components) and by Account generated from oneUNOPS is presented in Project Budget Balance report below.

Due to late approval of the AWP 2017, achieving the annual delivery target could be challenging without taking management measures. Similar to any regional projects, extensive consultation needed in making consensus over methodologies and terms of reference of activities among members of the RWGs may slow the contracting process for consultancies.

Management measures should be made in order to facilitate the achievement of annual delivery targets.

Recommendation:

- a) By August 20, the Secretariat complete all major TORs for consultancies;
- b) The Secretariat consult relevant RWG Chairs and Vice Chairs in writing on the methodologies and TORs of consultancy services;
- c) The Chairs and Vice Chairs of relevant RWGs communicate and provide joint responses to the request of the Secretariat within 10 working days; and
- *d)* The Secretariat closely follow up the implementation of the contracts to ensure timely submission of deliverables by the consultants or subcontractors.

Engaging DPR Korea

During the preparation stage of the YSLME Phase II project, DRP Korea submitted the letter of endorsement of the project to UNDP confirming its interest of participation. Due to special circumstances, UNDP was requested by the GEF to submit the project proposal without DPR Korea as a participating country. Being aware of the fact that it is unrealistic to invite DPR Korea representatives to participate in the inception workshop, the Secretariat has updated its embassy in Beijing of the inception workshop and provided electronic versions of meeting documents for sharing with its national counterpart agency of the YSLME Project in Pyongyang.

It is to the interest of all partners to revitalize the collaboration with DPR Korea in the project, with the objective of having the updated SAP jointly adopted by the three countries bordering the Yellow Sea. Having project meetings and workshops in RO Korea makes the participation of DPR Korea in project activities politically unrealistic.

Recommendation:

- a) The Secretariat consider organizing more events in China at the border city with DPR Korea, i.e. Dandong of Liaoning Province, or Secretariat Dalian Branch, to allow participation of DPR Korea counterparts in project activities possible and in a cost-efficient manner; and
- b) Furthermore, the Secretariat explore opportunities of financial support from UN Agencies or organizations with field operations in DPR Korea to facilitate the participation of DPR Korea colleagues in project meetings and workshops.

3.4 New opportunities/Initiatives

YSLME launches its intern program

On June 15, PMO has uploaded two opportunities for interns on UNOPS website which signifies the launch of the internship program of YSLME. The objective of the YSLME II Project Internship Program is to offer students or recent graduates the work experiences that would enhance their employability and/or skills and to provide a unique learning opportunity through a better understanding of UN values and culture in a diverse and international working environment.

YSLME Internship Program offers the internship opportunities through the following arrangements:

- UNOPS, which recruits interns in line with its internship policies and procedure. Internship opportunities will be published on UNOPS employment website and the Global Personnel Recruitment system (GPRS).
- MOU with participating governments in the Project. Under this arrangement, candidates will be nominated by governments.
- Incheon Metropolitan City "International Organizations Career Experience Program".
 Only students from collaborative universities with Incheon Metropolitan City of RO Korea are eligible for participation.

Internship lasts from a minimum of 3 months to a maximum of 12 months with duty station in Incheon, RO Korea. Current vacancies for internship include environmental law and communication.

The following requirements will be considered for the selection of an Intern:

- Academic and skills requirements
- Enrollment in a university degree program such as Bachelor, Masters or Ph.D. (or the equivalent), or have graduated from such studies within three years prior to the application date of the internship.
- Fluency in at least one of the UN official languages is required. Knowledge of a second UN official language is desirable.
